Information for each Energy Default or Judgment	C.	This form is to be completed separately for any defaults or judgments you are applying to have removed that are listed on your credit file from any energy company	
Information for each Telecommunication Default or Judgment	D.	This form is to be completed separately for any defaults or judgments you are applying to have removed that are listed on your credit file from any telecommunication companies. (Mobile phones, internet, home phone etc.)	
Information for all Other Defaults or Judgments	E.	This form is to be completed separately for all other defaults or judgments you are applying to have removed that are listed on your credit file from anything other than banking, financial institution, energy, or telecommunication company.
